These units are scheduled to vest in four equal quarterly installments such that they will be fully vested on the first anniversary of the date of grant (or, if earlier, the day before the next annual meeting of shareholders), subject to continuous service as a director. These units will generally be paid in an equivalent number of shares of the Company's common stock on the earlier of the last vesting date and the date the director's service terminates, subject to any election by the reporting person to defer payment.
