Explanation of Responses:

- These shares represent restricted stock units granted under the Yahoo! Inc. 1996 Directors' Plan. Each restricted stock unit represents the contingent right to receive, upon vesting of the unit, one share of Yahoo! common stock. These units are scheduled to vest ratably, in equal quarterly installments, over a one year period following the date of grant. Vested units will generally be paid in an equivalent number of shares of the Company's common stock on the earlier of the third anniversary of the grant date or the date the director ceases being a member of the board.
- JRC COHO LLC is wholly-owned by the reporting person and a trust for the benefit of the reporting person's son.
- This option is granted under the Yahoo! Inc. 1996 Directors' Plan and is scheduled to become exercisable at a rate of 1/4 of the securities underlying the option in equal quarterly installments over a one year period following the date of grant.
