On December 14, 2011, Yahoo! Inc., a Delaware corporation (“Yahoo!”), Alibaba Group Holding Limited, a company organized under the laws of the Cayman Islands (“Alibaba”), and Softbank Corp., a Japanese corporation (“Softbank”), consummated the transactions under the previously announced Framework Agreement, dated July 29, 2011, by and among Yahoo!, Alibaba, Softbank, Alipay.com Co., Ltd., a limited liability company organized under the laws of the People’s Republic of China (“Alipay”), APN Ltd., a company organized under the laws of the Cayman Islands (“IPCo”), Zhejiang Alibaba E-Commerce Co., Ltd., a limited liability company organized under the laws of the People’s Republic of China (“HoldCo”), Jack Ma Yun, Joseph C.
