Each restricted stock unit represents the contingent right to receive one share of Yahoo common stock. These units are scheduled to vest in four equal quarterly installments such that they will be fully vested on the first anniversary of the date of grant (or, if earlier, the day before Yahoo's next annual meeting of shareholders), subject to the reporting person's continuous service as a director. Vested shares will generally be delivered on the earlier of the last vesting date or the date the director's service terminates, subject to any election by the reporting person to defer payment.
