Explanation of Responses:

- These shares represent restricted stock units granted under the Yahoo! 1996 Directors' Stock Plan (the "Directors' Plan"). Each restricted stock unit represents the contingent right to receive, upon vesting of the unit, one share of Yahoo! common stock. These units are scheduled to vest ratably, in equal quarterly installments, over a one year period following the date of grant. These units will generally be paid in shares of the Company's common stock on the earlier of the third anniversary of the grant date or the date the director ceases being a member of the board.
- This option is scheduled to become exercisable at a rate of 1/4 of the securities underlying the option in equal quarterly installments over a one year period following the date of grant.

- This report amends the report previously filed which, due to an administrative error, incorrectly reported the date of grant of these awards as June 13,2007. Pursuant to the terms of the Directors' Plan, the correct date of grant was June 12,2007 (the date of the Company's 2007 Annual Meeting of Stockholders) and the per share exercise price of the options was \$27.05 (the closing price of a share of Yahoo! Inc. common stock on that date).
